**RECOGNITION ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, the institution had submitted application online on 30.05.2015 to the Northern Regional Committee of NCTE for grant of recognition/permission for Teacher Education Course.

2. AND, WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution in compliance to the decision of clause 7(13) of the NCTE Regulations, 2014, as amended from time to time the Northern Regional Committee having satisfied itself that the institution fulfils the requirements under the provisions of NCTE Act, Rules and the extant Regulations including the Norms and Standards for the proposed Teacher Education course, such as, instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the course and has selected/appointed qualified teaching staff as per norms duly approved by the affiliating body, decided to grant recognition/ permission to the institution in its 289<sup>th</sup> meeting held from 8<sup>th</sup> to 9<sup>th</sup> October, 2018 for B.Ed. course.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to the following institution for conducting Teacher Education programme with an annual intake mentioned against its name from the academic session 2019-2020 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014, as amended from time to time, subject to fulfilment of the conditions mentioned below: -

4. The institution shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014, as amended from time to time, and ensure the following before commencement of the session: -

- The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the examining body in terms of Clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall comply with condition laid down in clause 8(3) of the NCTE Regulations, 2014, as amended vide Notification on 29.04.2017 which provides as under:-

- An institution, which has been recognised by the Council shall obtain accreditation from an accrediting agency indentified by the Council within five years of the date of recognition.
